When the person turns eleven (11), the person may elect to remain in the Child Handler Class until the day before they turn twelve (12) or elect to move to the Junior Handler Class. Once moved, he may not return to the Child Handler Class.

JUNIOR HANDLER CLASS (JHC): (Schedule 05K): For persons of eleven (11), but under eighteen (18) years of age.

The mating of bitches within the precincts of the show is forbidden.

The Committee reserves the right to change a judge should the allocated judge be unable to officiate.

No other animal other than an exhibit entered may be on the premises.

All Exhibitors/Handlers/Owners are personally responsible for the control of their dogs at all times and shall be personally liable for any claims which may be made in respect of injuries which may arise or be caused by their dogs.
